Mr. Ryan opened the meeting, and announced that last week, Tuesday, February 14, 2023, was the last day for Party Enrollment Changes, to be eligible to vote in the Primary Election on June 27, 2023.

The General Office remained open until 12:00 Midnight, and the Borough Offices were open until 7:00 PM, to accept walk-ins.

Mr. Ryan stated that citywide, the Board received a total of 110 walk-ins.

The citywide breakdown of the number of walk-ins received, is as follows:

From January 1, 2023, and up until the enrollment cut-off on February 14, 2023, there have been a total of 4,729 enrollment changes, citywide.

The citywide breakdown of the total number of enrollment changes processed citywide, is as follows:

President Shamoun noted that there may be Committees that the Commissioners, as well as Commissioner Edmead, the newly appointed Democratic Commissioner of New York County, may wish to be a part of.

President Shamoun moved to schedule the next meeting date for Tuesday, February 28, 2023 at 1:30 P.M. Commissioner Edmead seconded the motion, which was adopted unanimously.
